Research requests and copies --- If greater than one hour, then hourly rate, plus per page copy fee. If less than one hour, then actual cost of copies, plus any applicable transmission fees.

Miscellaneous charges: applied case-by-case and charged as an actual cost. This could include the cost associated with preparing and transmitting the record for the appellate court or the cost of electronic media that may be needed for a specific case or request.
